- The plan is not to shut down the entire golf course (if purchased) but to refurbish hole by hole thus allowing revenue generation during refurbishment.
- Ken Goddard is working through the financials. There were some roadblocks as conversations with the RGCC did not start back up until June 2021. Goal is to have the financials ready to share with community the week of September 13<sup>th</sup>.
