Golf Course

- Met with Arnold Palmer. A Sr Designer came out and we are waiting on the quote to restore back to Arnold Palmer. Regardless if they proceed with Arnold Palmer designation, RV park will be removed.
- Work has started on hole 10 including the greens and sand traps.
- The grass is not dead it is dormant and will come back when in season. They plan is to extend the grass to the sidewalks.
- Also working on opening the putting green and driving range.
- o If the community wants to get rid of shrubs/trees near their homes, work with John/team will do it for them.
- Pump station was shot and down to 1.5 pumps. Ordered a new pump station that will be ready just in time for the reseeding in August.
- o Replace all the sprinkler heads on the driving range as previous owners removed them all.
- Better sense of timing on the opening of the golf course at the next meeting.
- Back nine could open by May but considering waiting until October when it is completely redone.
- Membership information is still being developed. There will be open houses once the food and beverage side of the house is ready.
- John would like the next open Board meeting to be at the clubhouse.
- The bar and pool area will most likely be opened first.
- Decision on carts will be made tomorrow (2/10) as to whether the current carts will remain or purchase new ones.
- Fitness center will be improved including classes e.g. yoga.

- Tent will go away eventually but we will need to build the new event center first.
- Mr. Quinn suggested; for the time being people could walk or ride on the cart paths if they desire to see the progress being made.
- New name Iron Wolf Golf and Country Club at the Refuge.
